PUBLIC CALL FOR TENDERS**

Tender documents will be available on the electronic tendering system (SEAO) as of April 4, 2024. Tenders will be received at Sutton Town Hall or electronically on the SEAO server, no later than **11:00 a.m. on April 22, 2024.**

The Town of Sutton is requesting bids for the replacement and rehabilitation of culverts on chemin de la Vallée Missisquoi. The work includes, but is not limited to, the replacement of one (1) rectangular culvert, 3500 mm wide x 4000 mm high, with weir and passage for wildlife connectivity, the supply and installation of a 600 mm-diameter pipe and the installation of a passage for wildlife connectivity, the insertion of three (3) 450 mm to 600 mm diameter culverts, the repair and stonework of an existing culvert, ditch cleaning, pavement structure repairs, paving and pavement marking, as well as all other related work, including various repairs and other work required for the complete execution of the planned works.

Only contractors who have requested plans, specifications and tender documents in their own name, whose principal place of business is located in Quebec, Ontario or New Brunswick, and who are licensed under the Act respecting the qualification of building contractors, are eligible to bid.

**Bids must be accompanied by the following documents:**

- A bid bond equal to ten percent (10%) of the bid amount valid for a period of **ninety (90) days**, including an undertaking to provide a performance bond for the work and payment for materials and labour established at an amount of fifty percent (50%) each of the bid cost.

Bids must be submitted in a **sealed envelope in three (3) copies** and deposited at the Town Hall of Sutton at **11, rue Principale Sud, Sutton (QC) J0E 2K0** or **filed electronically on the SEAO server**. The deadline for filing a complaint concerning the adjudication or award process for public bodies is April 15, 2024.

Bids will be opened publicly or according to sanitary guidelines in effect at that time immediately after closing time at the Town Hall office. If a public opening is not possible, a record of the bid opening will be available on the electronic tendering system (SEAO) after the bid opening.

The Town of Sutton does not undertake to accept the lowest or highest or any of the bids received without incurring any obligation or costs of any kind to the bidder(s).
