IN ZONE P-07 »

NOTICE is hereby given to interested persons and organizations:

That at the regular meeting held December 7, 2020, the Municipal Council of the Town adopted, by resolution number 2020-12-484 the first draft of By-Law number 115-15-2020 entitled « By-Law modifying Zoning By-Law number 115-2, as amended, in order to integrate the class use P103 « Uses under the aegis of a public, governmental or non-profit body in education, health and social services, in administration public or municipal, including educational institutions, local community service centers, etc. in zone P-07 ».

A written consultation on the first draft of By-Law number 115-15-2020 will be held as follows:
