  - the advance poll will be held on March 17, 2024, from 12 p.m. to 8 p.m.
  - the polling day will be held on March 24, 2024, from 10 a.m. to 8 p.m.
- 4. You can vote by mail if your domicile is not located in the territory of the municipality. To vote by mail, you must make a written application sent to the returning officer no later than March 12, 2024. The ballot papers for voting by mail will be sent as of March 12, 2024. If you are registered to vote by mail and you have not received your ballot papers on March 18, 2024, you can contact the Returning Officer to obtain new ones. Ballot papers must be received at the office of the Returning Officer no later than Friday, March 22, 2024, at 4:30 p.m.
- **5.** Chantal Marien was appointed to act as election clerk and is authorized to receive nomination papers.
- **6.** Pierre Labrosse was appointed to act as Returning Officer's Assistant and is authorized to receive nomination papers.
