**PUBLIC NOTICE  
REGISTRATION OF QUALIFIED VOTERS**

---

**PUBLIC NOTICE IS HEREBY GIVEN BY THE UNDERSIGNED TO QUALIFIED VOTERS HAVING THE RIGHT TO BE REGISTERED ON THE REFERENDUM LIST OF THE TOWN:**

**By-law number 335 entitled « By-law decreeing an expense of \$ 900,000 and a loan of \$ 900,000 for the replacement and purchase of a mechanical shovel and a 12-wheel truck »**

**THAT** a notice of motion was given on May 1<sup>st</sup>, 2024, at a regular meeting.

**THAT** the draft By-Law number 335 was tabled on May 1<sup>st</sup>, 2024, at a regular meeting.

**THAT** By-Law number 335 was adopted on **June 5, 2024**, at a regular meeting.

**THAT** the purpose of By-Law number 335 is:

1. To authorize the awarding of a contract, the loan and the necessary expenditures up to a maximum of \$ 900, 000, to acquire a new mechanical shovel and a 12-wheel truck to replace two existing ones, as announced in the capital expenditures program 2024-2025-2026.
2. To authorize the council to spend an amount of \$ 900,000 for the purpose of the said By-Law.
3. To authorize the council **to borrow an amount of \$ 900,000 over a period of ten (10) years.**
4. To tax and levy, annually, during the term of the loan, **on all taxable immovables**, whether built or not, located in the territory of the Town, **a special tax** at a rate sufficient according to their value as it appears on the assessment roll in force each year.

**Register | Request for a referendum poll**

**THAT** qualified voters having the right to be registered on the referendum list of the Town may ask that By-law number 335 be the subject of a referendum poll by entering their name, address and capacity, and by affixing their signature, in a **register opened for this purpose.**

**THAT** the register will be accessible from **9:00 a.m. to 7:00 p.m.** on **June 21<sup>st</sup>, 2024**, at the Town Hall located at 11, Principale Sud Street in Sutton.

**THAT** the number of requests required for a referendum poll on By-law number 335 is **four hundred and fifty one (451).**

**THAT** if this number is not reached, By-law number 335 is deemed to be approved by those qualified voters.

**THAT** the results of the registration process will be announced at 7:05 p.m. on June 21<sup>st</sup>, 2024, at the Town Hall located at 11 Principale Sud Street in Sutton.

**Conditions to be a qualified voter having the right to be registered on the referendum list**

**THAT** qualified voters wishing to register their names **must present identification** (driver's license, passport, health insurance card, certificate of Indian status, Canadian Forces identification card).

**THAT** the conditions to be a qualified voter having the right to be registered on the referendum list of the designated sector are:

1. Any natural person who, on June 5, 2024, is not disqualified from voting in accordance with article 524 of the *Act respecting elections and referendums in municipalities* and fulfills the following requirements:
  - 1.1. **Is a natural person domiciled in the municipality** and for at least six (6) months domiciled in the Province of Quebec and
  - 1.2. **Is of full age** and a Canadian citizen and not under curatorship.

2. Is **the sole property owner who is not a resident of an immovable, or sole occupant who is not a resident of a business establishment**, who is not disqualified from voting, and fulfills the following requirements:
  - 2.1. For at least twelve (12) months, is the owner of an immovable or sole occupant of a business establishment located in the municipality.
  - 2.2. In the case of a physical person, be of full age and a Canadian citizen and not under curatorship.
3. Is **the undivided co-owner who is not a resident of an immovable or co-occupant who is not a resident of a business establishment**, who is not disqualified from voting and fulfills the following requirements:
  - 3.1. For at least twelve (12) months, is the undivided co-owner or co-occupant of a business establishment in the municipality.
  - 3.2. Be designated by the means of **a power of attorney signed** by the majority of the persons who are co-owners or co-occupants for at least twelve (12) months, as the person who has the right to be entered, on their behalf, on the referendum list. This written power of attorney must be submitted before or at the time of signing the register.
4. If the qualified voter is a **legal person**, this person **must be designated by resolution**, among its members, administrators or employees, who on June 5, 2024, and who at the time of exercising this right, is of full age, a Canadian citizen, not under curatorship or disqualified by law to vote.

\*This person must be of legal age and a Canadian citizen. He or she must not be under curatorship or have been convicted of an offence that constitutes a corrupt electoral practice. The person must not be entitled to have his or her name registered on the list of electors or the referendum list in a higher-ranking capacity than that of the co-owner of the building or co-occupant of a business establishment.

### 3 SIGNATURE OF THE CO-OWNERS OR CO-OCCUPANTS

Signatories must be electors or qualified voters. Most co-owners or co-occupants must sign. If there are only two co-owners or co-occupants, **both parties must sign.**
